

The 2025 Hilltop Hunt Hosted by HilltopSecurities (the "Promotion") Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

- 1. **Eligibility:** The Promotion is open only to Pre-K through 12th grade educators working within public or charter institutions accredited by the Texas Education Agency (TEA). This includes private schools accredited by the Texas Private School Accreditation Commission (TPSAC). Educators affiliated with childcare centers, daycare facilities, nursery schools, or other early childhood programs not part of either the TEA or TPSAC -accredited Pre-K–12 institution are not eligible to participate. Employees, contractors, directors and officers of Hilltop Securities Inc.
